

AN ORDINANCE OF THE CITY OF HANFORD AMENDING  
SECTION 10.16.130(B) OF THE HANFORD MUNICIPAL CODE  
PERTAINING TO PROHIBITED PARKING

The City Council of Hanford does hereby ordain as follows:

Section 1. Section 10.16.130(B), Prohibited Parking, of the Hanford Municipal Code is hereby amended to read as follows:

1. A new Subparagraph (2) shall be added to read as follows: "2. 9 ¼ Avenue – the west side, from 375' north of the centerline of Summer Field Drive to 70' north.
2. A new Subparagraph (7) shall be added to read as follows: "7. Florinda Street – the south side, from 75' west of the centerline of Harris Street to 70' west.
3. A new Subparagraph (9) shall be added to read as follows: "9. Greenfield Avenue – the south side, from 235' west of the centerline of Campus Drive to 70' west.
4. Subparagraphs (2) through (16), inclusive, are hereby renumbered (3), through (19) inclusive, in accordance with the above addition and re-alphabetizing.

Section 2. This Ordinance shall take effect thirty (30) days after its passage and shall be published once in the Hanford Sentinel within fifteen (15) days after its passage.
